Overview

Because of the armed aggression of the Russian Federation, starting from 24 February 2022, 1864 thousand hectares of forests or 18% of the total area of the forest fund of Ukraine were located in temporarily occupied territories of 11 regions of Ukraine (Dnipro, Donetsk, Zhytomyr, Zaporizhzhia, Kyiv, Luhansk, Mykolaiv, Sumy, Kharkiv, Kherson, Chernihiv) and Kyiv city. The total growing stock in these areas amounts to 395 million cubic metres.

Additionally, since 2014 year 497 thousand hectares of forests have been occupied in the Autonomous Republic of Crimea, Donetsk and Luhansk oblasts. The total growing stock in these territories amounts to 67 million cubic metres.

Thus, 2362 thousand hectares of forests have been impacted by the war, which corresponds to nearly 23% of the total area of the forest fund of Ukraine. Total frowing stock in these territories amounts to roughly 462 million cubic metres.

In terms of administrative units, the share of forests located in the temporarily occupied territories is (was) as follows:

- in the Autonomous Republic of Crimea, Luhansk and Kherson regions 100%;
- in Dnipro 0.2%, Donetsk 61.9%, Zhytomyr 11.8%, Zaporizhzhia 61.6%, Kyiv 43.4%, Mykolaiv 18.9%, Sumy 63.7%, Kharkiv 42.2% and Chernihiv 59.8%.

The forests of state forestry enterprises under the management of the SFRA amounted to: in 2014 - 358.6 thousand hectares (72.1%), in 2022 - 1192.6 thousand hectares (64.0%) and in total - 1551.2 thousand hectares or (65.7%) of the total area of Ukrainian forests located in the temporarily occupied territories.

The current report includes the areas of the forest fund that were respectively still are under occupation, which were directly affected by the armed aggression of the Russian Federation, within forestry enterprises, structural units (forestries), etc. For this purpose, we used:

- a. Materials of the State Enterprise "Ukrderzhlisproekt", created on the basis of information obtained from official and open sources of information, remote sensing data, and overlaid on the forestry mapping database "Areas and reserves of forests located (located) in the temporarily occupied territories as a result of the armed aggression of the Russian Federation as of 01.07.2022";
- b. Handbook on the Forestry Fund of Ukraine based on the state forest accounting as of 01.01.2011 (compiled by specialists of the production and technological department of the SE "Ukrderzhlisproekt" based on the state forest accounting as of 01.01.2011, the results of which were approved by the order of the SFRA of Ukraine dated 29.03.2012 No. 122);
- c. Distribution of forestry land area by categories of forestry enterprises and institutions subordinated to the SFRA as of 01.01.2019, ha (according to the geographic information base of the SE "Ukrderzhlisproekt").

However, it should be noted that source a. above takes into account the maximum size of the temporary occupation (which did not increase until the end of 2022), it includes information only on forests that were provided for permanent use and for which forest management materials were developed.

In addition to these forests, on the territory of the above mentioned 11 oblasts, there were about 479 thousand hectares of forests (including 222.7 thousand hectars field protection forest belts) on the reserve lands that were not provided to the author, no forest management was carried out in them and their condition is not actually known, in particular by oblast (total area of /of which field protection forest belts, thousand hectares):

Impacts of war aggression on state forestry enterprises of SFRA

As a result of the armed aggression of the Russian Federation, starting from 24 February 2022, 1192.6 thousand hectares of forests or 16.3% of the total forest area of state forestry enterprises belonging to the State Forestry Agency (SFRA) were located in the temporarily occupied territories of 11 regions of Ukraine (Dnipro, Donetsk, Zhytomyr, Zaporizhzhia, Kyiv, Luhansk, Mykolaiv, Sumy, Kharkiv, Kherson, Chernihiv). The total growing stock in these areas is 267.53 million cubic metres.

It should be noted that since 2014, the temporarily occupied territories of the Autonomous Republic of Crimea, the city of Sevastopol, Donetsk and Luhansk regions included 358.6 thousand hectares of forests, or 4.9% of their total area. The total growing stock in these territories is 51.74 million cubic metres.

Thus, 1551.2 thousand hectares of forests are (were) located in the temporarily occupied territories, which is 21.3% of the total area of forests of state forestry enterprises belonging to the sphere of management of the SFRA. The total growing stock in these areas is 319.27 million cubic metres.

In terms of administrative units, the part of the forest fund that is (was) under temporary occupation is as follows:

- in the Autonomous Republic of Crimea, the city of Sevastopol, Luhansk and Kherson regions 100%;
- in Dnipro 0.3%, Donetsk 61.7%, Zhytomyr 12.6%, Zaporizhzhia 60.5%, Kyiv 37.9%, Mykolaiv 15.5%, Sumy 64.5%, Kharkiv 41.9% and Chernihiv 66.1%.

Below is an analysis (for 2021 and the first half of 2022) of the production and financial activities, use of forest resources, reproduction, protection and conservation of forests by state forestry enterprises belonging to the sphere of management of SFRA in 11 regions of Ukraine that suffered the consequences of armed aggression after 24.02.2022. The analysis was carried out on the basis of reporting documents of regional forestry and hunting departments, in particular

- materials of SFRA for consideration at board meetings:
- Results of economic and financial activities of the industry enterprises for the first half of 2021;
- Materials on the results of the work of the enterprises of SFRA of Ukraine for 2021;
- Results of economic and financial activities of the industry enterprises for the first half of 2022;
- Information on the state of activity of the enterprises of SFRA of Ukraine subordinate to the public sector of the economy in the context of Russian aggression (current, as of 24.06.2022).

It should be taken into account that due to the temporary occupation, no reports on the production and financial activities of state forestry enterprises in Donetsk, Luhansk and Kherson regions were prepared.

The armed aggression led to a sharp decline in economic activity due to the temporary occupation of the territory, shutdown of enterprises, physical destruction of facilities, loss of equipment, high level of uncertainty and risks, disruption of logistics and production ties, and forced mass migration of the population. In addition, the operations took place in the context of a general economic downturn, rising inflation and rising prices.

As of 24.02.2022, there were 68 forestry enterprises operating in 11 regions of Ukraine affected by the armed aggression, which belonged to the sphere of management of the SFRA. As a result of the armed aggression, 33 forestry enterprises (49%) were partially damaged. As of 24.06.2022, 34 (50%) carried out production activities, 16 (24%) partially carried out production activities, and 18 enterprises (26%) did not work. In addition, there were 22 state forestry enterprises in the territories temporarily occupied since 2014, including 12 in the Autonomous Republic of Crimea, 1 in Sevastopol, 5 in Donetsk region, and 4 in Luhansk region.

The volume of illegal logging increased by 1.9 thousand cubic metres (45%), and the amount of damage caused increased by 4,588.5 thousand UAH (12%).

Assessment of damage and losses for forested lands, forest nurseries, forest regeneration of state forestry enterprises of SFRA

The procedure for determining the damage and losses caused to Ukraine as a result of the armed aggression of the Russian Federation (hereinafter referred to as damage and losses), starting from 19 February 2014, is established in accordance with the Procedure for Determining the Damage and Losses Caused to Ukraine as a Result of the Armed Aggression of the Russian Federation, approved by Resolution of the Cabinet of Ministers of Ukraine No. 326 dated 20 March 2022 (as amended by Resolution of the Cabinet of Ministers of Ukraine No. 951 dated 22 July 2022).

The amount of damage and losses is calculated in accordance with the Methodology for Determining Damage and Losses Caused to the Forest Fund as a Result of the Armed Aggression of the Russian Federation, approved by Order of the Ministry of Environmental Protection and Natural Resources of Ukraine No. 414 dated 05.10.2022, registered with the Ministry of Justice of Ukraine on 24 October 2022 under No. 1308/38644.

The methodology is used to determine the damage and losses caused to forestry land plots, linear-type protective plantations, forest nurseries, forest crops and hunting grounds as a result of the armed aggression of the Russian Federation, including the loss of forest plantations and related losses:

- losses of forestry production caused by restrictions on land users' rights;
- losses of damaged, lost harvested timber products;
- lost revenues of forest users caused by temporary occupation of land plots, restrictions on their use, from:
- failure to conduct logging (cost of timber products, rent);
- inability to carry out side use (in particular, harvesting birch juice, berries, mushrooms);
- costs of soil preparation for forest crops;
- costs of growing planting material in forest nurseries, creating and maintaining forest crops.

The following analytical assessment of damages was made for state forestry enterprises belonging to the sphere of management of the State Forestry Agency, which were (are) located in the temporarily occupied territories as a result of the armed aggression of the Russian Federation, after 24.02.2022, and is based on enlarged, aggregated initial data, indirect methods of assessment, taking into account the provisions of the Methodology for determining damage and losses caused to the forest fund as a result of the armed aggression of the Russian Federation, indicators of state forest accounting and reporting documents of regional forestry and hunting departments.

Losses in forestry production caused by restrictions on the rights of permanent forest users amount to UAH 75631.3 million. The following indicators were used for calculations:

- The coefficient of land productivity reduction (1-K) was established on an estimated basis, taking into account the period of temporary occupation and the nature of land damage;
- average amount of losses per 1 ha in accordance with the Standards of forestry production losses set out in paragraph "b" of the Annex to the Resolution of the Cabinet of Ministers of Ukraine No. 1279 of 17 November 1997 "On the Amount and Procedure for Determining Losses of Agricultural and Forestry Production Subject to Compensation";
- area of the damaged or mined area according to Table 2.

Note: there is a inconsistency between the regulatory legal acts (the Standards for forestry production losses set out in paragraph "b" of the Annex to the Resolution of the Cabinet of Ministers of Ukraine of 17 November 1997 No. 1279 "On the Amount and Procedure for Determining Losses of Agricultural and Forestry Production Subject to Compensation" and the Methodology for Determining Damage and Losses Caused to the Forest Fund as a Result of the Armed Aggression of the Russian Federation, approved by the Order of the Ministry of Ecology and Natural Resources of Ukraine No. 414 of 05.10.2022, registered with the Ministry of Justice of Ukraine No. 1308/38644) on the classification of certain categories of forests into groups of forests.

In particular, the Standards for forestry production losses set out in paragraph "b" of the Annex to the Resolution of the Cabinet of Ministers of Ukraine of 17 November 1997 No. 1279 "On the Amount and Procedure for Determining Losses of Agricultural and Forestry Production Subject to Compensation" do not contain relevant indicators for the second group of forests in the Dnipro, Donetsk, Zaporizhzhia, Luhansk, Mykolaiv, Kharkiv and Kherson regions.

In view of the above, the average amount of losses for the second group of forests was assumed to be the same as for the first group of forests.

The total amount of damage and losses caused to forestry land plots, forest nurseries, and forest crops caused by the restriction of land users' rights is estimated at UAH 80659.4 million (EUR 2077.8 million), which consists of

- losses of forestry production 93.72%;
- losses due to damaged or lost harvested timber products 0.18%;
- lost income from not conducting logging 4.12%;
- expenses due to the impossibility of harvesting secondary forest materials and making side use of forests, using useful properties of forests, and farming - 0.06%;
- costs of soil preparation for forest crops 0.02%;
- damage and losses caused to forest nurseries and forest crops 1.90%.

Losses caused to the state due to unauthorised use of forest lands (lost income) of permanent forest users of the SFRA

The state's lost income from the use of forest areas covered with forest vegetation as a result of the armed aggression of the Russian Federation is estimated at UAH 4,816.3 million (EUR 124.8 million). The calculations are based on the state forestry records and updated data of the State Enterprise "Ukrderzhlisproekt" on the area offorest plots covered with forest vegetation and annual changes in the stock, as well as on the reporting data of the regional forestry and hunting departments on the actual average weighted market price of timber.

All losses of the forest fund as a result of the armed aggression of the Russian Federation after 24.02.2022 caused to the state and losses caused to permanent forest users of SFRA on forestry land plots are estimated at UAH 85511.9 million (EUR 2201.8 million), which consist of

- damages caused to the state ("lost income") UAH 4816.3 million (EUR 124.8 million);
- losses caused to permanent forest users UAH 80659.4 million (EUR 2077.8 million).

The amount of other damage and losses on forestry lands, including those caused to buildings, structures, and objects under construction, was not assessed due to the lack of initial data necessary for the assessment and relevant information sources for part of the temporarily occupied territory due to the ongoing hostilities.

Summary

1. In the temporarily occupied territories there were respectively are:

- in 2014 497.4 thousand hectares of forests (4.8%) of Ukraine with a total growing stock of 67.07 million cubic metres (3.2%), including 358.6 thousand hectares of forests (4.9%) of state forestry under SFRA with a total growing stock of 51.74 million cubic metres (3.4%);
- from 24.02.2022 1864.4 thousand hectares of forests of Ukraine (18.0%) with a total growing stock of 394.4 million cubic metres (18.8%), including 1192.6 thousand hectares of forests (16.3%) of state forests under administration of SFRA with a total growing stock of 267.53 million cubic metres (17.7%);
- a total of 2361.8 thousand hectares of forests in Ukraine (22.8%) with a total growing stock of 462.06 million cubic metres (22.0%), including 1551.2 thousand hectares of forests (21.3%) of state forests under SFRA with a total growing stock of 319.27 million cubic metres (21.1%).

2. Consequences of armed aggression after 24.02.2022 for state forestry enterprises of the SFRA are:

- out of 68 forestry enterprises located in the temporarily occupied territories, 33 (49%) were partially damaged. As of 24.06.2022, 34 (50%) were engaged in production activities, 16 (24%) in partial production activities, and 18 enterprises (26%) were not operating;
- net income from the sale of products (works, services) decreased by UAH 641.1 million (17%), payments to the state (payment of taxes, fees, unified social tax) decreased by UAH 137.2 million (9%);
- the number of full-time employees decreased by 4.1 thousand people (24%), the average monthly salary decreased from 1% to 59%;
- harvesting of liquid timber decreased by 1240.3 thousand cubic metres (42%), including from the main use logging on 701.2 thousand hectares (47%);
- the volume of illegal logging increased by 1.9 thousand cubic metres (45%), and the amount of damage caused increased by 4588.5 thousand UAH (12%)
- the number of forest fires increased almost 3 times, and their area increased 106 times:
- the volume of forest reproduction decreased by 5.7 thousand hectares (43%), including the planting of forests by 4.2 thousand hectares (37%).

3. Forestry losses caused to the state and damages caused to permanent forest users of the SFRA

According to the analytical assessment of the amount of forestry losses caused to the state and damages caused to permanent forest users of the SFRA on forestry land plots located in the temporarily occupied territories as a result of the armed aggression of the Russian Federation after 24.02.2022:

 In general, all losses of the forest fund as a result of the armed aggression of the Russian Federation after 24.02.2022 caused to the state and losses caused to permanent forest users of the SFRA on forestry land plots are estimated at UAH 85511.9 million (EUR 2201.8 million), including damages caused to the state (lost income) - UAH 4816.3 million (EUR 124.8 million);

- losses caused to permanent forest users 80659.4 million UAH (2077.8 million EUR),
 of which:
 - losses of forestry production 75631.3 million UAH (1947.4 million EUR);
 - losses due to damaged or lost harvested timber products UAH 144 million (EUR 3.7 million);
 - lost income from not conducting logging UAH 3323.1 million (EUR 85.6 million);
 - expenses due to the impossibility of harvesting secondary forest materials and making side use of forests, using useful properties of forests, and farming
 UAH 51.8 million (EUR 1.3 million);
 - costs of soil preparation for the creation of forest crops UAH 14.4 million (EUR 0.4 million);
 - damage and losses caused to forest nurseries and forest crops UAH 1530.8 million (EUR 39.4 million).

4. Total economic losses

Within the administrative regions, all losses of the forest fund as a result of the armed aggression of the Russian Federation after 24.02.2022, caused to the state, and losses caused to permanent forest users of the SFRA on forestry land plots are as follows:
